Conditions of Use of a Trader's Plate

The following conditions apply to the use of a Trader's Plate. A motor vehicle may be standing or driven on a public street where:

1. The vehicle is roadworthy.
2. The vehicle is in the possession or custody of the trader to whom the plate has been issued (or transferred) for manufacture, repair, painting, sale or exchange, or delivery to another trader, purchaser or owner.
3. The vehicle is being used for a bona fide purpose connected with manufacture, repair, testing, painting, sale or exchange, or delivery to another trader, purchaser or owner.
4. Any person (in or upon the vehicle) is carried other than for hire or any consideration, and is bona fide interested in, or employed for, a purpose mentioned in 3.
5. The vehicle is not being used for hire purposes, or for consideration of any kind, whilst a trade plate is attached.
6. Any load carried in or on the vehicle is being conveyed solely for the purpose of demonstrating the mass-carrying capacity of the vehicle to a bona fide prospective purchaser.
7. In the case of a towing vehicle owned by the trader, the vehicle is being used for the purpose of proceeding to, and towing, any disabled vehicle.
8. The driver or person in charge of the motor vehicle is:
 - a) the trader or an employee of the trader;
 - b) A prospective purchaser accompanied by the trader or an employee of the trader, where the trader is not a licensed motor vehicle dealer (LMVD);
 - c) A prospective purchaser, where the trader is licensed as a motor vehicle dealer (LMVD).
9. The Trader's Plate attached to the vehicle has a current label.
10. A Trader's Plate is attached to the rear of the vehicle whilst in use in a public area.
11. Any trader who is the holder of a Trader's Plate is required to record the details of use. The record entered into the Trader's Plate Register must record:
 - a) the date, plate number, make, purpose of the trip, and trip times; and
 - b) the driver's name, address, licence number, signature and comments.

The particulars are to be recorded in the Trader's Plate Register within 24 hours, after the time any vehicle to which a trader's plate is attached, leaves the dealership/workshop, and applies to all Trader's Plate holders.
12. The Trader's Plate Register is to be made available for inspection by the Registrar, an inspector from Motor Vehicle Registry or a member of the Police Force.

Privacy Statement

The Registrar of Motor Vehicles is required to collect information for Registrations, Licenses and Permits under section 92 of the NT *Motor Vehicles Act*.
