Notes for Guidance

This statutory declaration (Notice of Disposal) is required to satisfy the requirements of;

- NT *Uncollected Goods Act*
- NT *Motor Vehicles Act*
- NT *Taxation (Administration) Act*

This statutory declaration (Notice of Disposal) must be completed by the receiver (seller) and presented to MVR accompanied by a receipt that satisfies the requirements of section 30 of the NT *Uncollected Goods Act* within 14 days of the sale or disposal of a vehicle. MVR form R33 has been developed to satisfy this requirement. You should also use this notice to advise MVR when a vehicle has been written-off, given/sold to a motor vehicle wrecker, etc.

The Notice of Disposal will not be processed if the receipt is not presented with this Statutory Declaration. Penalties under the *Motor Vehicles Act* may apply.

The registered owner/operator may still be responsible for the vehicle, including liability for any parking or traffic infringements (including demerit points where applicable), until the Notice of Disposal is accepted by MVR.

Privacy Statement

The Registrar of Motor Vehicles is required to collect information for Registrations, Licenses and Permits under section 92 of the NT *Motor Vehicles Act*.
