Prerequisites for Attendance on Pilot/Escort Operator Training Program

Oversize Load Pilot Operator

- i) Applicant must possess a current “C” Class Driver’s Licence (minimum).
- ii) Applicant must satisfy the Registrar of Motor Vehicles that he/she is a fit and proper person in order to obtain the necessary Oversize Load Pilot Vehicle Operator’s Licence (current criminal history required).
- iii) Applicant must satisfy the Registrar of Motor Vehicles that he/she is experienced in the heavy transport industry and the movement of oversize loads.
- iv) Two work related references to be supplied upon application.

Oversize Load Escort Operator

- 1) Applicant must possess a current “C” Class Driver’s Licence (minimum).
- 2) Applicant must satisfy the Registrar of Motor Vehicles that he/she is a fit and proper person in order to obtain the necessary Oversize Load Escort Vehicle Operator’s Licence (current criminal history check required).
- 3) Applicant must satisfy the Registrar of Motor Vehicles that he/she is experienced in pilot vehicle operations, e.g. must have piloted a minimum of ten (10) loads in a two (2) pilot situation and five (5) loads involving an Oversize Escort Operator (log book or other relevant proof to be supplied).
- 4) One written work related character reference to be supplied upon application.
- 5) Recognised first aid qualification (desirable only).
