Substitute Taxi Record Book

This record book has been compiled in conjunction with the Department of Lands and Planning and members of the taxi industry peak body working group.

This record book is to be filled out when the substitute taxi, the registration number of which appears on the front cover, is being used in place of a normal taxi (substituted).

It is the responsibility of the person whose name appears on the substitute taxi commercial vehicle licence, to ensure the safe keeping of this book and it is their responsibility to ensure the records are kept up to date.



Failure to keep this book in the substitute taxi or failure to ensure the records are kept up to date may result in penalties ranging from an infringement notice being issued to cancellation of the substitute taxi commercial vehicle licence.

This record book must be presented to an Inspector upon request.

Insert the **date** the substitute taxi started operating in place of a normal taxi.

Insert the date the substitute taxi ceased operating in place of a normal taxi.

Clearly print the name of the operator whose name appears on the substitute taxi commercial vehicle licence.
OR
The name of a person authorised by that operator to authorise the substitution i.e. Taxi driver.

Insert the signature of the operator whose name appears on the substitute taxi commercial vehicle licence.
OR
The signature of a person authorised by that operator to authorise the substitution.

Insert the time the substitute taxi started operating in place of a normal taxi.

Insert the time the substitute taxi ceased operating in place of a normal taxi.

Insert the registration number of the taxi that is being replaced by the substitute taxi.

Insert the reason why the substitute vehicle is being used, i.e. Why is the normal taxi not being used? Proof supporting the substitution reason may be required to be supplied.
