GUIDANCE FOR APPLICATION FOR RECOGNITION OF AN *OVERSEAS* MARINE QUALIFICATION

Northern Territory recognition may be issued in respect of an overseas marine qualification for use on voyages subject to the *NT Marine Act*, after:

- providing the **original** certificate(s) or a verified copy of all pages of your certificate(s) including pages which show any endorsements/restrictions, etc;
- providing proof of identification – refer to Guidance Note No. 46/2000;
- completion and return of the application form (refer page 2); and
- payment of 58 Revenue Units for each certificate recognition applied for.

- 1 Revenue Unit = \$1.00

Please note:

- NT recognition will be based on current Uniform Shipping Laws (USL) Code limitations.
- On approval, you will be issued with a Northern Territory “Letter of Recognition” to be kept with your original certificate of competency for operations subject to NT Legislation.
- It will take up to 15 working days to action this application, but may take longer subject to verification and authenticity checks to the flag state of issue.

PRIVACY STATEMENT

The Department of Lands and Planning is collecting the information on this form to assess your eligibility for a marine qualification as required under the *Northern Territory Marine Act*.

This Department may give some or all of this information to State marine authorities, the Australian Marine Safety Authority or other government bodies as required by legislation.

Failure to provide the information in full or in part may mean that you will not be issued with a marine qualification.
